Milpitas Unified School District

CASSY just completed the second year of our partnership with MUSD. We started this year with therapists providing mental health support at Milpitas High School, Calaveras Hills High School, the new Community Day School, and Russell and Rancho middle schools. Beginning in January 2013, we expanded to six elementary schools-Burnett, Curtner, Pomeroy, Randall, Sinnott, and Weller. Our therapists delivered approximately 490 student assessments and 4,450 therapeutic sessions across the district.

Los Gatos High School/Fisher Middle School

For the fourth consecutive year, Los Gatos High School contracted CASSY to deliver a comprehensive mental health program which included direct counseling, crisis intervention and parent and staff consultation. We also offered peer mediation and suicide and depression awareness classes and have expanded our services to include Special Education students that require counseling as part of their Individual Education Plan (IEP). CASSY also just completed our second year at RJ Fisher Middle School where we provided 25 hours per week of social and emotional support on-campus.

Palo Alto Unified School District

CASSY just completed the second year of our partnership with six PAUSD elementary schools-Duveneck, Escondido, Juana Briones, Nixon, Ohlone and Walter Hays. CASSY provided individual, family and group counseling on-campus during school hours at each school. Our therapists delivered approximately 265 student assessments, 2,305 therapeutic sessions, 718 parent consultations and 1,476 staff consultations during the school year.
